CRITERIA FOR HONORARY PAST GRAND MATRON AND HONORARY PAST GRAND PATRON

The Grand Worthy Matron possesses the authority, honor and privilege to award the rank and title of Honorary Past Grand Matron or Honorary Past Grand Patron upon a Past Matron or Past Patron who have served and supported the NC Grand Chapter Order of the Eastern Star with commitment, honor and dedication.

Criteria:

Honorary Past Grand Matron: A Chapter can recommend a Past Worthy Matron of their chapter for the honor, rank and title of Honorary Past Grand Matron who is

- a. Is in good financial standing and is seventy (75) years of age
- b. Has forty (40) years of continuous service
- c. Has served the NC Grand Chapter Order of the Eastern Star as an appointed or elected officer
- d. Has received a 2/3 approval vote from the Chapter (attach a copy of the minutes with this form).
- e. Worthy Matron shall write a one-page (minimum) Letter of Recommendation for this honor.

Honorary Past Grand Patron: A Chapter can recommend a Past Worthy Patron of their chapter for the rank, honor and title of Honorary Past Grand Patron who is

- a. Is in good financial standing and is seventy (75) years of age
- b. Has forty (40) years of continuous service
- c. Has served the NC Grand Chapter Order of the Eastern Star as an appointed or elected officer
- d. Has received a 2/3 approval vote from the chapter (attach a copy of the minutes with this form).
- e. Worthy Matron shall write a one-page (minimum) Letter of Recommendation for this honor.
